

Privacy Policy

I. - Who is responsible for the processing of your data?

This privacy policy (hereinafter, the "Privacy Policy") applies to all personal data provided by the user to *GEORGE POPA CONSTRUCT SLU*, with address at CALLE BAUTISTA BERTOMEU SOBER NR12, SHIP 2, POL. IND. CASA GRANDE, 03183 TORREVIEJA, ALICANTE, SPAIN

For the purposes of this Privacy Policy, "User" must be understood as any natural person interested in the products and services that *GEORGE POPA CONSTRUCT SLU* offers to its customers and through its website. *GEORGE POPA CONSTRUCT SLU*, as responsible for the processing, will request, prior to the provision of their personal data, the User's express consent to this Privacy Policy, when necessary and any other aspect that requires the prior authorization of the User. Same, the objective of the Privacy Policy of the *GEORGE POPA CONSTRUCT SLU* is to give transparency to the information of how we treat your data and to protect the information on the Internet and the data that the user may enter on the web.

The User may contact the Legal and Regulatory Compliance Office of *GEORGE POPA CONSTRUCT SLU* through gmp_construct@yahoo.com in case of any doubt or need regarding data protection.

II. - With what purpose do we treat your personal data?

The User is hereby informed that *GEORGE POPA CONSTRUCT SLU* will be able to process the personal data that the User provides through the online forms or during the purchase process of any of the products, for the purposes indicated below, to the extent that there is a legal basis for each treatment as explained below:

- (a) Guarantee the User access to and use of their personal space in the private area of the web pages of products and services offered by *GEORGE POPA CONSTRUCT SLU*.
- (b) Manage purchases and requests made by the User in person and on the web pages of *GEORGE POPA CONSTRUCT SLU*
- (c) Inform the User by any means, including the sending of commercial communications to the e-mail address provided by the User, of *GEORGE POPA CONSTRUCT SLU* products and services similar to those acquired by the User.
- (d) Carry out promotional activities about other *GEORGE POPA CONSTRUCT SLU* products and services, including the sending of commercial communications to the email address provided by the User.
- (e) Carry out promotional activities, including the sending of commercial communications to the email address provided by the User by *GEORGE POPA CONSTRUCT SLU*, of products or services of third-party collaborators of *GEORGE POPA CONSTRUCT SLU*. All of this, as long as we ask the User for his consent for it and he grants it to us.

III. - What is the legitimacy for the treatment of your personal data?

- The legal basis for the processing of the data for purpose (a) and (b) is the execution of the contract for the provision of services and / or the purchase of the corresponding products.
- The legal basis for the treatment of the data for the purpose (c) will be both the consent of the User, in case it has been requested and granted, and the legitimate interest of

GEORGE POPA CONSTRUCT SLU in bringing to your knowledge similar products or services to those who have previously acquired.

- The legal basis for the treatment of the data for the purposes (d), (e) and is the consent that could have been requested to the User, without any case the withdrawal of the same condition the execution of the contract of provision of services. The personal data of the User will not be processed for these purposes in case *GEORGE POPA CONSTRUCT SLU* has not requested their consent.

GEORGE POPA CONSTRUCT SLU, at the time of registration, will collect and process the personal data essential for the registration and access to the personal space of the User. In the event that he decides to acquire one of the products or services of *GEORGE POPA CONSTRUCT SLU*, *GEORGE POPA CONSTRUCT SLU* will collect and process the necessary data to manage the contracting process (among them, name, surnames, ID, address, etc.). The User knows and accepts that the non-completion of certain personal data will prevent *GEORGE POPA CONSTRUCT SLU* from providing all those services linked to such data. In any case, *GEORGE POPA CONSTRUCT SLU* will cede, exploit these data or use them for a different use from the one expressly indicated here. During the registration process, the User will be informed of the non-obligatory nature of the collection of some of the data for the provision of *GEORGE POPA CONSTRUCT SLU* services.

IV. - How long do we keep your personal data?

GEORGE POPA CONSTRUCT SLU will keep the data of its clients for the duration of their contractual relationship and after that, the data will be kept for promotional actions for a period of two years, for another type of users the data will also be maintained for a period of two years , (except, in both cases, that the treatment was based on the User's consent and the User revokes it, in which case they will be kept until such revocation is received) therefore, the data will not be kept longer than necessary for the purposes described above, without prejudice to the conservation that is necessary for the formulation, exercise or defense of potential claims and / or whenever permitted by applicable legislation.

V. - Who has access to your personal data?

An optimal provision of the service that *GEORGE POPA CONSTRUCT SLU* offers may require other third party service providers of *GEORGE POPA CONSTRUCT SLU* to access the personal data of the User as responsible for the treatment. By accepting this Privacy Policy, the User understands that some of the aforementioned service providers are located in countries outside the European Economic Area or that they do not offer a level of security equivalent to Spanish. In these cases, the transfers are based on the authorization of the Directorate of the Spanish Control Authority, in model clauses approved by the Commission or, as the case may be, on the Privacy Shield. To obtain more information about the previous guarantees or the fact that they have been provided, you can contact *GEORGE POPA CONSTRUCT SLU* through the means established in section I.

In addition to the accesses that third-party providers may have to the personal data, *GEORGE POPA CONSTRUCT SLU* is responsible for treatment, national or international, within the framework of providing a service to the person responsible for processing, *GEORGE POPA CONSTRUCT SLU*, may assign the Personal data of the User to the authorized Distributors of *GEORGE POPA CONSTRUCT SLU*, as mentioned in section II, provided that he had requested the consent of the User and that the latter had granted it.

In addition to the above, *GEORGE POPA CONSTRUCT SLU* may make assignments or communications of personal data to meet its obligations to the Public Administrations in cases that are required in accordance with the legislation in force at any time and, where appropriate, to other bodies such as State Security Forces and Bodies and Judicial Bodies.

VI. - What are the rights of users?

GEORGE POPA CONSTRUCT SLU informs the User about the possibility of exercising the rights of access, rectification, opposition, deletion, portability and limitation of the treatment as well as to reject the automated processing of personal data collected by *GEORGE POPA CONSTRUCT SLU*. Said rights may be exercised free of charge by the User, and in his case whoever represents him, by written and signed request addressed to the following address: Bautista Bertomeu Sober nr12, Nave 2, Pol. Ind. Casa Grande, 03183 Torrevieja, Alicante, Spain. Said request must contain in the subject the reference "Data Protection / [Name of the *GEORGE POPA CONSTRUCT SLU* company]" and must include the following information: User's name and surname, address for notifications, photocopy of the National Document of Identity or Passport, and request in which the request is specified. In the case of representation, it must be proved by a reliable document. Likewise, the User may exercise the aforementioned rights through the email gmp_construct@yahoo.com. In addition to the foregoing rights, the User shall have the right to withdraw the consent granted at any time through the procedure described above, without such withdrawal of consent affecting the lawfulness of the treatment prior to its withdrawal. *GEORGE POPA CONSTRUCT SLU* may continue to treat the User's data to the extent permitted by applicable law.

Likewise, when the treatment of the User's personal data for the purpose (c) is based on the legitimate interest, the User may oppose it.

GEORGE POPA CONSTRUCT SLU reminds the User that they have the right to submit a claim to the relevant control authority.

VII.- Drop in the service of sending commercial communications

As mentioned in the previous section, the User has the right to revoke at any time the consent given for the sending of commercial communications with the simple notification to *GEORGE POPA CONSTRUCT SLU* by which he informs that he does not wish to continue receiving commercial communications. For this purpose, the User may either revoke his consent in the manner described in the previous section or click on the link included in each commercial communication thus canceling the sending of electronic commercial communications.

VIII.- From what age can the User access our products and services?

The *GEORGE POPA CONSTRUCT SLU* website is not directed to minors under 18 years of age. By accepting this Privacy Policy the User declares and guarantees that he is over 18 years of age.

IX.- What security measures are implemented?

GEORGE POPA CONSTRUCT SLU is committed to fulfilling its obligation of secrecy of personal data and its duty to keep them, and will take the necessary measures to prevent alteration, loss, treatment or unauthorized access, in accordance with the provisions of regulations applicable. *GEORGE POPA CONSTRUCT SLU* has implemented the necessary technical and organizational security measures to guarantee the security of your personal data and to avoid their alteration, loss and treatment and / or unauthorized access, taking into account the state of the technology, the

nature of stored data and the risks to which they are exposed, whether from human action or from the physical or natural environment, in accordance with the provisions of the applicable regulations. *GEORGE POPA CONSTRUCT SLU* concerned about privacy, in order to strengthen the confidentiality and integrity of information in your organization, continuously monitor, control and evaluate their processes to ensure respect for privacy and security of information, according to standards international
